### Jigar Shah

Jigar Shah is the former CEO and current board member of the Carbon War Room, a global organization founded by Richard Branson and Virgin United. Mr. Shah is also the Founder of SunEdison, which is recognized as the catalyst of the power purchase agreement (PPA) business model that helped turn solar PV into a multi-billion dollar industry worldwide. Shah previously worked with BP Solar and the Department of Energy and is the author of Creating Climate Wealth: Unlocking the Impact Economy (2013).



#### **David Hochschild**

David Hochschild was appointed to the California Energy Commission by Governor Jerry Brown in February 2013. Hochschild was a Special Assistant to San Francisco Mayor Willie Brown in 2001 where he launched a citywide \$100 million initiative to put solar panels on public buildings. He went on to co-found the Vote Solar Initiative, a 60,000-member advocacy organization promoting solar policies at all levels. Mr. Hochschild also served as Executive Director of a national consortium of leading solar manufacturers.



### Geof Syphers

Geof Syphers is CEO of Sonoma Clean Power, the new Community Choice electricity provider in Sonoma County. A licensed mechanical engineer and a pioneer in the green building field, Mr. Syphers managed utility energy efficiency programs and consulted on over \$1 billion in completed California developments. Mr. Syphers is the former Chief Sustainability Officer for Codding Enterprises and the founding Director of Sustainable Buildings and Communities at KEMA Energy & Sustainability (now DNV-GL).



## Robyn Beavers

Robyn Beavers is the founder and Senior Vice President of Station A Group, an internal innovation team focused on microgrid strategy at NRG Energy, the largest solar power developer in the US. In 2004, Ms. Beavers joined Google as direct support to the cofounders while the company went public. She went on to form Google's Green Business and Operations Strategy Group, its first business unit focused on sustainability strategy. Ms. Beavers also helped create a global NGO called WindMade for Vestas Wind Systems.



# Mike Lemyre

Mike Lemyre is the Vice President of Ygrene Energy Fund, where he leads the development of Property Assessed Clean Energy (PACE) financing programs that have established Ygrene as a market leader in this field. For the majority of the past decade, Lemyre has held senior positions at both Chartis (formerly AIG) and the Arch Insurance Group. Lemyre also founded and launched a wireless application development company, an insurance software product firm and a successful marketing and event planning company.

# **Community Choice Energy May Revolutionize Our Energy Grid**

"No money down" financing has made installing solar much easier for many property owners. But for every customer with a good credit score and south facing roof, there are many others without such advantages. Enter Community Choice Energy. It promises to overcome barriers to renewable energy development while modernizing and decentralizing the electricity system.

California's first and second Community Choice programs, Marin Clean Energy and Sonoma Clean Power, offer cleaner power and lower rates than PG&E. Sonoma Clean Power estimates that in 2014 alone more than \$6 million will stay in the local economy because of their favorable power procurement.

The success of these two Community Choice programs has inspired communities up and down the state. Currently San Diego, Sunnyvale, Mountain View, Alameda, Monterey, San Luis Obispo, Lancaster, among others, are seriously exploring starting Community Choice programs because it is the most cost-effective, powerful tool under local control to reduce greenhouse gas emissions.

Community Choice is a local program that buys and generates electricity for businesses and residents. The investor-owned utility like PG&E continues to provide customer service, maintain power lines, transmit power, and handle the billing. It is an agile public-private partnership.

Investing in local clean energy will make the energy system more resilient over time and will keep costs stable by reducing dependence on the volatile market for fossil fuels. Locally produced energy also reduces the considerable expense of adding new transmission lines by producing more power closer to where it is consumed.

With Community Choice Energy, some communities could jump to micro grids where electricity is both consumed and produced on the premises. Community Choice is really best positioned to accelerate the deployment of proven technologies that are underutilized like the intelligent grid in California. To do so they will need political savvy and private partners with expertise, technologies, and financing to help them interface with large private utilities to integrate renewable energy into the system.

The Climate Protection Campaign, a proponent of Community Choice since 2005, is hosting The Business of Local Energy symposium. Leading experts will describe innovative programs available now as well as programs planned for the near future. They will explore how to optimize Community Choice as a gamechanging innovation platform for developing local energy, stimulating local economic development, and increasing the resiliency of the grid.

Cisco, Enphase Energy, Siemens, ChargePoint, Tesla, and Green Charge Network will participate in the discussion with the operators of Sonoma Clean Power and Marin Clean Energy, researchers, regulators and policymakers focused on how to increase local renewable power generation while keeping rates competitive.

Cleantech companies have the human and capital resources, and experience in bringing start up ventures to scale necessary to unleash the potential of Community Choice. It can help revolutionize the way we produce, deliver, and consume energy for the benefit of customers, the economy, and the environment.

2001 - Founding

**2002** – National Precedent 1: Sonoma County and 9 cities pledged to climate protection

**2003** - National Precedent 2: Sonoma County and 9 cities complete emissions inventories

2005 - National Precedent 3: Sonoma County and 9 cities set goal to cut emissions by 25%. Began education about Community Choice as a game-changing solution.

**2008** - Community Climate Action Plan issued

2009 - Sonoma County Energy Independence Program and Regional Climate Protection Agency founded

**2010** - Windsor Efficiency PAYS program began

2011 - Sonoma Clean Power exploration began by Sonoma County Water Agency

2013 - Five cities join Sonoma Clean Power; North Bay Business Journal names Sonoma Clean Power year's top story

**2014** - Sonoma Clean Power goes live serving customers
