Climate-Safe California: Over the last year The Climate Center has developed a major new initiative to reduce greenhouse gas emissions at speed and scale. Climate-Safe California is a comprehensive campaign to align California climate targets and policies with the current science. Recent scientific findings which are referenced on The Center's website indicate that the pace of climate change is accelerating and that we are experiencing impacts much greater and sooner than previously predicted. We developed the Climate-Safe California platform with input from scientists, academics, economists, businesses and other nonprofits working in the field. (Continued at Schedule O)

Community Choice Energy/Clean Power Exchange: Clean Power Exchange is The Center's program that advances the expansion Community Choice Energy (CCE) across California. CCE is a program available to local governments that allows them to buy and generate cleaner electricity for businesses and residents. CCE is one of the most powerful measures a local community can take to significantly and rapidly reduce its greenhouse gas emissions. The Clean Power Exchange website is a hub of resources, information, and news for stakeholders across California interested in Community Choice. We track communities' progress toward Community Choice implementation. (Continued at Schedule O)

Community Resilience (formerly Advanced Community Energy): Over the last year The Climate's Center has focused on how we can move California to a 21st century electricity system which is more decentralized, clean, affordable, resilient, equitable, and safe. We made detailed comments to the California Energy Commission as part of their 2019 Integrated Energy Policy Report workshop encouraging them to create a handbook for local governments with guidance on the development of clean microgrids to support critical facilities during planned and unplanned outages, and on participatory planning approaches to identify local needs and priorities for energy planning. ECO2school: ECO2school is a service-learning program teaching climate literacy and leadership skills to high school students. Teens promote walking and biking to their peers to reduce emissions and achieve long-term personal, community, and environmental health. It was a difficult year for our program as this is an on-campus approach and with the pandemic all school campuses were closed starting in March. Even with these challenges ECO2school was able to provide education and mentorship at 17 Sonoma County high schools and the Santa Rosa Junior College. Our regional program reached another ten schools in six Bay Area counties. ECO2school staff implemented youth leadership trainings with 125 Sonoma County students. These students designed and implemented education and encouragement activities that reached 6,646 students and 2,186 community members. During the shelter in place restrictions ECO2school implemented a weekly newsletter. It reached 235 students and 115 teachers for the last eleven weeks of the school year. We also sponsored an online "Tell Your Climate Story" contest. Forty-two students from across the Bay Area shared stories through video which were viewed by over 2,100 people on the website. According to self-reported numbers by participants they reached 15,673 people with their stories. The Climate Center has moved our organizational strategy toward policy that leverages climate action at scale and away from direct implementation through youth programs, so the ECO2school program was successfully transitioned in the end of June to Daily Acts, a nonprofit located in Sonoma County.

down more warming compounds from the atmosphere than we are emitting, creating an example for the rest of the country and the world. In addition to working to build a coalition around the Climate-Safe California framework, we launched a monthly Climate Friday webinar series that engaged over 2,000 people. In May we began making presentations to elected officials, businesses, and the general public and asking them to endorse Climate-Safe California. We secured 277 total endorsements by the end of June, including 32 organizations, 25 businesses, and growing. Climate-Safe California is now the organizing roadmap behind all of The Center's activities. In June we created new budget program areas to address the policies and support functions needed to achieve Climate-Safe California's goals: 2030 Targets, Phase Out Fossil Fuels, Natural Sequestration, Funding Climate Action along with Mobilizing and Policy.

Clean Power Exchange: (continued from page 3) We share resources, news, and we offer a series of webinars designed to accelerate adoption of best practices. There are now 21 CCE programs operating in California, serving approximately 11 million customers power that is 88% clean energy. The Center has also been actively promoting CCE in the Central Valley to disadvantaged communities that have serious air quality issues. The city of Stockton (population of 310,000) is developing a Request for Proposal for a feasibility analysis to evaluate for CCE. The city of Fresno (population 527,438) has also voted to do a feasibility study. The Center was also selected with our partners, MCE Clean Energy and TerraVerde Energy by the California Energy Commission for a project to empower Community Choice agencies to use a sophisticated data-based approach to program development to support distributed clean energy in multi-family housing, commercial and public facilities, residential applications, and to optimize the value of these resources to customers and the grid.

We also formally commented on a proceeding to the California Public Utility Commission on how to reform the state's bankrupt utility, PG&E, suggesting that new business model for regulated monopoly utilities is needed. This model includes more collaboration with local governments, and incentivizing the utilities to operate the distribution system as an open access platform that other third-party providers can bid distributed energy resources, like solar and storage, into. Utilities would focus on balancing the electricity load at the distribution level, accelerating the development of decentralized clean generation, and providing more flexibility to the grid, greater emissions reductions, and resilience to the local community. The Center has built a coalition of organizational partners to help develop a Community Energy Resilience initiative to communicate this decentralized clean energy vision, identify the barriers, and develop policy to address what is needed to overcome them. One way we communicated this vision was through a four-part webinar series on Community Energy Resilience with a component for local governments, businesses, and schools. The series started in June and each online event featured expert speakers in the relevant areas and was attended by hundreds of participants. The series had some high level participants from state government, including a state senator, and a commissioner from the California Public Utility Commission and the California Energy Commission, contributing to the development of sound state policy on energy resilience.
