Policy Development & Implementation

This year, The Climate Center pursued climate policy in California in five main areas: natural carbon sequestration, carbon dioxide removal, defending funding for existing climate priorities in the state budget, divesting state employee pension funds from oil and gas companies, and using the batteries in electric vehicles to provide power to our homes, businesses and the grid when needed.

In 2022, The Climate Center co-led a coalition of over 80 organizations to pass a historic natural carbon sequestration law, AB 1757, requiring the state to set ambitious targets for 2030, 2038 and 2045 and to develop other natural climate solutions. We organized a group of environmental and conservation nonprofit organizations to give input into an extensive process led by California Natural Resources Agency, California Air Resources Board and California Department of Food & Agriculture that culminated in setting the actual scientific targets for carbon sequestration across six land types. As a result the state is positioned to over the next 20 years to transform over 50 million acres into healthier, climate-resilient landscapes, spanning farms, ranches, forests, grasslands, and wetlands.

The UN's Intergovernmental Panel on Climate Change prescription is clear: we must cut emissions in half by 2030 AND remove upwards of a trillion tons of carbon that we have already put in the atmosphere to stabilize the climate. The Climate Center is working to educate the environmental and environmental justice community in California on the need for carbon dioxide removal (CDR) and the various options that have been initiated or are planned. We have also worked closely with Senator Becker

on his SB 308, Carbon Dioxide Removal Market Development Act, which would require the the California Air Resources Board to adopt regulations to require certain emitting entities to purchase negative emissions credits equal to a specified amount of their greenhouse gas emissions in each calendar year beginning in the 2028 calendar year. Our role is to work with environmental justice and environmental partners to ensure that there are adequate protections for local communities that are subject to CDR development in the bill. The bill has passed the senate and is headed to the assembly.

We also worked leading a coalition of organizations around climate budget defense. This year California faced a \$45 billion budget deficit. The Governor's early proposed budget contained significant cuts to the historic climate investments committed to by the state in 2022. Although large cuts and delays to climate priorities were still part of the final budget, the coalition was able to work with legislators to prevent hundreds of millions in proposed cuts to key state climate programs, including:

- Reversed \$100 million in cuts to the Active Transportation Program, which funds biking and pedestrian infrastructure.
- Directing the California Air Resources Board (CARB) to ensure that existing clean car incentive programs for low-income and disadvantaged communities can continue operating making the best use of the money available.
- Restored funding for offshore wind port investments
- Preserved \$551 million in the Equitable Building Decarbonization Program (EBD) in the 2024-2025 budget

We also educated legislators and the public about the hundreds of millions, potentially billions of dollars in subsidies that are available through state tax

code to oil and gas companies at the same time the industry is making record profits in California. We hope to get a state agency to provide a detailed analysis on what these subsidies are actually costing the state, so that legislators have the information that they need to close these loop holes.

Another way that we worked with partners to try to provide the funding needed for climate adaptation and mitigation was working on a climate bond. There were two bills in the assembly and one in the senate related to the climate bond. The Climate Center's focus on the bond, which ended up representing \$10 billion in climate investments, was to work with partners to ensure that natural and working lands were a significant part of the investment. The bond was voted out of the legislature and will be on the November ballot for California voters to decide if they want to support these climate investments. We will work with a broad coalition to educate the public about how these investments will create a healthier and safer California, as well as help the state meet its statutory climate goals.

We also worked with Senator Gonzalez's office and other partners on SB 252 the Fossil Fuel Divestment Act. This bill would have prohibited the California Public Employees Retirement System (CalPERS) and the California State Teachers Retirement System (CalSTRS) from investing in fossil fuel companies, and would require that they divest any current holdings in these companies by 2030. Unfortunately, after passing through the senate the bill could not get through a policy committee in the assembly.

We worked with Senator Nancy Skinner on SB 59, a bill that aims to unlock the potential for millions of electric vehicles that will be sold in California to power homes during outages, lower energy bills for Californians, reduce air pollution, and

make the electricity grid more reliable. The bill would authorize the California Air Resources Board to require that electric vehicles (EVs) sold in California have bidirectional capability. We are working with 200 organizations from across the state to help this bill become law by September 2024. This policy could be a significant part of ensuring that we have enough storage and flexibility in our electricity system to incorporate all the intermittent renewable energy that we need to get to our clean energy goals.

In addition to our priority legislation, we played a significant role in helping pass a couple of climate bills focused on corporate accountability. We supported the passage of Senator Wiener's SB 253, the Climate Corporate Data Accountability Act, into law. This law will require all large, U.S.-based corporations doing business in California that make more than \$1 billion annually to publicly disclose their full carbon footprint in a way that is easily understandable and available to the public. We also worked for the passage of SB 261, Senator Stern's bill which requires corporations to submit to the California Air Resources Board, and make available to the public on its own website, a report that discloses climate-related financial risk. Now that the Governor signed these two bills into law, we are working to ensure that they are funded by his administration. We are concerned that they are slow walking the implementation of these historic and critical laws.

Our signature campaign, Climate-Safe California, offers a roadmap for climate action in the world's fifth-largest economy. Climate-Safe California is a set of policies that would enable California to remove more climate pollution from the atmosphere than we emit as soon as possible while creating thousands of jobs and repairing environmental injustices. Climate-Safe California – and all of The Climate Center's work – is guided by three core principles: follow the latest science, prioritize climate justice, and secure a just transition for workers. Currently, we have over 2,469 total endorsements from nonprofits, businesses, elected officials, cities, counties and other governmental bodies, and individuals.

We have also built and engage with diverse coalitions to realize relevant policy components of Climate-Safe California, especially on facilitating community energy resilience with local scale solar and storage, setting aggressive emission reduction targets, phasing out fossil fuels, scaling up nature-based carbon sequestration, and securing the necessary funding for speed and scale implementation.

Sacramento. We had over 400 people registered with featured speakers including Lauren Sanchez, the Governor's Senior Climate Advisor, who spoke about the impact of oil and gas production on frontline communities, and numerous senators and assembly members from the California legislature. This event was followed by The Climate Center's Advocacy Day, during which participants met with 48 legislative offices and discussed critical climate policies.

This year we produced nine webinars with more than 2,600 registrants. The webinars covered the science of the climate crisis, the impacts of the fossil fuel economy on local communities, a recap of the accomplishments and unfinished business of the 2023 CA legislative session, the impact of California's budget deficit on state climate programs, and key climate policy solutions for consideration by California's state decision makers. Presenters included California state legislators, state regulators, environmental justice groups, and community members.

As an official Observer NGO The Climate Center helped organize the attendance of California delegation of decision makers at COP 28, in Dubai. We hosted an official UN side event on natural carbon sequestration and the importance of healthy soils with state officials, and international collaborators, held two press conferences, and organized an event on California's climate accomplishments that included the Speaker of the CA Assembly, three senators and one additional assembly member. We also hosted private events including an international panel on what is needed for a managed transition away from fossil fuels, the appropriate role for green hydrogen, and harnessing the power of nature in achieving the world's 1.5 C goal. COP is an opportunity to educate leaders from other parts of the world about climate solutions that California is leading on as well as an opportunity for state lawmakers to learn

about and be inspired about solutions being implemented in other countries.

Our efforts have also garnered significant media coverage in California, raising public awareness and building momentum for accelerated, equitable climate action. This year, we were quoted, cited, or mentioned in 84 news stories between July 2023 and June 2024 and we published two op-eds (Governor Newsom: Save lives, not fossil fuel corporations, Capitol Weekly, April 18, 2024 and A Sacramento fossil fuel lobbyist bragged about corrupting the democratic process, Sacramento Bee, July 22, 2023). We've also held events for supporters in Los Angeles and San Francisco to highlight our work.

This year, we produced a policy report called Reforming California's Cap and Trade Program. The California Cap and Trade Program plays a pivotal role in the state's efforts to reduce greenhouse gas emissions. A review of the program ahead of the upcoming 2025 compliance period has opened a critical window of opportunity to address and correct the program's recognized shortcomings. In this policy brief, we outline three crucial enhancements to improve the effectiveness of the program in advancing California's climate goals. At the same time the California Air Resources Board is doing a public reassessment of the cap and trade program, particularly around reducing the oversupply of pollution allowances on the market. We have submitted a couple of public comment letters to CARB with our partners to push CARB to be aggressive in restricting allowances and make other necessary reforms to the program.

Our team is also working on a paper that will address California's current electricity affordability crisis by laying out a clear vision for a future
