

Public Outreach and Communications

The Climate Center has pursued multiple outreach strategies to educate decision-makers and the public about the urgency of the climate crisis and the array of accelerated, equitable solutions that the state can pursue now to address it. We published four policy briefs; hosted twelve webinars with over 5,000 total registrants; convened the 2025 California Climate Policy Summit in Sacramento (sold out with over 400 attendees); organized legislator attendance at the 2024 UN Climate Conference in Baku, Azerbaijan where we hosted three side events and press conferences; generated 69 media mentions of our work; and mobilized our supporters to take over 12,500 online actions.
